EXHIBITOR RULES

1. Exhibitor's fee is \$40.00 per Exhibitor for a 10'X10' Exhibitor space. Fee is not refundable for any reason. No Exhibitor fee for non-selling, 501c3 non-profit organizations, providing we have space available.
2. ALL EXHIBITORS MUST have a canopy. No electricity is available to Exhibitors and generators are not allowed in any form. Exhibitors must commit to exhibit from 9:00 am to 3:00 pm. No early breakdown.
3. Only Artists and Craftsmen displaying original work may participate in the juried portion with monetary awards. Buy/sells are limited and accepted only after review. No garage sale items allowed. If you are exhibiting with us for the first time, please e-mail two photos of your art/craft/wares, in a booth setting, to dscainc@bellsouth.net for approval prior to application (not required for returning Exhibitors). Photos sent via regular mail will not be returned.
4. No pornographic materials in any form will be accepted. Festival Board reserves the right to define 'pornographic' and retains the right to remove offending work or request Exhibitors vacate the show without refund.
5. Exhibitor Application and payment must be sent together via regular mail. Make checks payable to: "DeLeon Springs Community Association, Inc." Submit Application and payment to P.O. Box 271, DeLeon Springs, Fl., 32130 by March 22, 2019. The Festival Board reserves the right to reject applications without explanation.
6. Exhibitors are required to provide their own canopy, shelving, racks, etc. and be prepared for a variety of weather, insects, etc., as this is an outdoor event, located under trees.
7. Exhibitors are responsible for collecting their own Florida sales tax.
8. Early set up is offered at your own risk on Friday April 12th beginning at 5:00 p.m. Check-in and set up for all Exhibitors will begin at 7:15 a.m. on Saturday April 13th. Booths remaining empty at 8:00 a.m. will be re-assigned to other Exhibitors. There is no parking at Exhibitor sites and autos must be removed by 8:30 a.m. to the parking location. Exhibitors must be present and with their booth throughout the entire Festival.
9. **For the health of our Festival attendees, Exhibitors will not smoke tobacco or vapor products at their booth.**

The undersigned requests to be allowed to participate in the Art Among The Trees Juried Art, Craft and Music Festival. In consideration of my participation, I assume full responsibility for any risk of bodily injury, death and/or property damage due to the Porter House property owners' negligence of any kind and/or their representatives. I do hereby release and forever discharge the DeLeon Springs Community Association, Inc., Porter House property owners and their representatives (Released Parties) from all manner of actions, suits, and sums of money, damages, controversies, claims and demands from any loss or damage to the undersigned's person or property. I give the Released Parties permission to use/take photographs of me for the use of publicity of the event without compensation and I waive any claim that may arise from use of said photographs.
