Application must be included with payment after photos have been approved. Make checks payable to “DeLeon Springs Community Association, Inc.” Check in will begin at 7:15 a.m. Saturday April 14th. Booths remaining empty at 8:30 a.m. will be re-assigned to other artists. There is no parking at Artist’s site. Artists must unload and remove autos prior to setting up. Artists and Craftsmen must be present and with their booth throughout the entire Festival. No garage sale items allowed. Break down will not occur before 3:00 p.m. No refunds for any reason. Early set up at your own risk is allowed beginning at 5:00 p.m. Friday, April 13th.

ARTIST AND CRAFTSMAN RULES

(RETURN THIS PORTION)

PLEASE READ AND SIGN THE FESTIVAL RULES:

1. Only artists and craftsmen displaying their own, original work may participate. No garage sale or used items accepted unless repurposed in original art work.
2. Application fee is \$40.00 per Artist, non-refundable with a commitment to exhibit from 9:00 am to 3:00 pm, no early breakdown. **Application deadline is March 30th.**
3. Artist spaces are approximately 11'x11'; no electricity provided, no generators.
4. Artists are required to provide their own canopy, shelving, racks, etc. and be prepared for a variety of weather as this is an outdoor event, located under trees.
5. Artist photos must be sent via e-mail, Artist Application via regular mail with payment. Artist photos may be sent via regular mail but will not be returned. Artist confirmation will be sent via e-mail. **Checks should be made payable to: DeLeon Springs Community Association, Inc.** and mailed to "Festival Board" at P.O. Box 271, DeLeon Springs, Florida, 32130. Festival Board retains the right to reject application and fee without explanation.
6. Artists are responsible for collecting their own Florida sales tax.
7. No pornographic materials in any form will be accepted. Festival Board reserves the right to define 'pornographic'. Festival Board retains the right to remove offending work and/or request the Artist vacate the show with no refund.
8. Artists may begin set up at 7:15 a.m. Artist spaces remaining empty at 8:30 a.m. will be re-assigned to other Artists. There is no parking at Artist spaces and autos must be removed by 8:30 a.m. Exhibitors must be ready to show by 8:45 a.m.
9. Artists must be present and with their booth throughout the entire Festival.

The undersigned requests to be allowed to participate in the Art Among the Trees Festival. In consideration of my participation, I assume full responsibility for any risk of bodily injury, death and/or property damage due to the Porter House property owners' negligence of any kind and/or their representatives. I do hereby release and forever discharge the DeLeon Springs Community Association, Inc., Porter House property owners and their representatives from all manner of actions, suits, and sums of money, damages, controversies, claims and demands from any loss or damage to the undersigned's person or property. I give the Released Parties permission to use/take photographs of me for the use of publicity of the event without compensation and I waive any claim that may arise from use of said photographs.
